For An Act To Be Entitled

10 AN ACT TO PROVIDE LEAVE FOR STATE EMPLOYEES TO
11 PARTICIPATE IN THEIR CHILDREN'S EDUCATIONAL
12 ACTIVITIES; AND FOR OTHER PURPOSES.

14 AN ACT TO PROVIDE LEAVE FOR STATE
15 EMPLOYEES TO PARTICIPATE IN THEIR
16 CHILDREN'S EDUCATIONAL ACTIVITIES.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. NOT TO BE CODIFIED. Legislative intent. The purpose of
23 this act is to allow state employees an opportunity to participate in their
24 children's educational activities by granting eight (8) hours of children's
25 educational activity leave per calendar year.
26

27 SECTION 2. Arkansas Code Title 21, Chapter 4, Subchapter 2 is amended
28 to add an additional section to read as follows:

29 21-4-216. Leave for participation in children's educational
30 activities.

31 (a) As used in this section:

32 (1) "Child" means a person enrolled in prekindergarten through
33 grade 12 (preK-12) who is of the following relation to a state employee:

34 (A) Natural child;

35 (B) Adopted child;



- 1 (C) Stepchild;
- 2 (D) Foster child;
- 3 (E) Grandchild;
- 4 (F) Ward of the state employee by virtue of the state
- 5 employee having been appointed the person's legal guardian or custodian; or
- 6 (G) Any other legal capacity where the employee is acting
- 7 as a parent for the child;

8 (2)(A) "Educational activity" means any school-sponsored
 9 activity.

10 (B) "Educational activity" includes without limitation:

- 11 (i) A parent-teacher conference;
- 12 (ii) Participation in school-sponsored tutoring;
- 13 (iii) Participation in a school-sponsored volunteer
- 14 program;
- 15 (iv) A field trip;
- 16 (v) A classroom program;
- 17 (vi) A school committee meeting;
- 18 (vii) An academic competition; and
- 19 (viii) Assisting with athletic, music, or theater
- 20 programs;

21 (3) "State agency" means an agency, a bureau, a board, or a
 22 commission of any branch of state government and all state-supported
 23 institutions of higher education; and

24 (4) "State employee" means a full-time employee of the State of
 25 Arkansas or any branch, department, board, bureau, commission, or state-
 26 supported institution of higher education.

27 (b)(1) All state employees shall be entitled to eight (8) hours of
 28 leave during any one (1) calendar year for the purpose of attending or
 29 assisting with the educational activities of a child.

30 (2) Leave under subdivision (b)(1) of this section:

31 (A) That is unused may not be carried over to the next
 32 calendar year; and

33 (B) Is not compensable to the state employee at the time
 34 of retirement.

35

36 SECTION 3. EMERGENCY CLAUSE. It is found and determined by the

1 General Assembly of the State of Arkansas that this act adds to the
2 provisions of the Uniform Attendance and Leave Policy Act and that the ideal
3 time to implement this change to the state's leave policies is at the
4 beginning of the state's fiscal year. Therefore, an emergency is declared to
5 exist and this act being necessary for the preservation of the public peace,
6 health, and safety shall become effective on July 1, 2007.
